Campaign contributions are not deductible for federal or state income tax purposes. Campaign finance laws limit individual State Party state account contributions to a maximum of \$5,000 per calendar year per individual. Contributions will be deposited into the state account until the maximum is reached. Contributions from corporate and labor organizations are prohibited by law and are not accepted by the Party. The Federal Election Campaign Act prohibits any foreign national from contributing, donating or spending funds in connection with any federal, state, or local election, either directly or indirectly. Note: Under state law, the combined contribution limit to all committees of any one party is \$5,000 per calendar year. Under federal law, the combined contribution limit to all state, district & local party committees of any one party is \$10,000 per calendar year.
